Key Findings & Highlights

Mindtree is an IT services vendor focused on continuous transformation and full stack services. It supports its clients with engagements delivering process automation, analytics, digital transformation, mobility, and cloud computing. Mindtree's lending services focus on:

- Transforming client platforms to solution stacks (microservices architecture)
- Improving customer experience in their channel interactions with lenders
- Supporting rearchitecting of the client operational ecosystem
- Shift the client's technology focus from running IT to developing new financial products supported on an as-needed basis with IT ops
- Providing emerging solution functionality

Mindtree has been increasing its partnerships with emerging solution vendors and services providers to expand its range of capabilities and access to clients. In May 2022, it announced its intention to merge with LTI to enable it to become a tier-one Indian services vendor. This proposed merger would provide scale and new service offerings to enable upsell to clients.
