WNS provides services across various industries: BFSI, CPG, healthcare, life sciences, hi-tech and professional services, manufacturing, retail, shipping and logistics, travel and leisure, and utilities and energy.

WNS' healthcare practice is the third largest business unit within the organization and contributed ~22% of the company's global revenue in FY23. In the U.S., they work with five of the top ten payers, TPAs, Medicare, Medicare Advantage, and Medicaid health plans.
